## ORDER ON MOTIONS AND SCHEDULING ORDER

Presently before the Court are a series of motions filed by Petitioners Valerie C. Santilli, individually and as Executrix of the Estate of John C. Chakalos (the "Estate"), Elaine Chakalos, and Charlene Gallagher. See Index ##35-38. There have been no responses or objections filed them, see Cir. Ct. – Prob. Div. R. 58, and as such, the Court ENTERS the following orders:

• The Petitioners' Motion to (I) Amend Petition and (II) File Certain Exhibits Under Seal, see Index #36, is GRANTED IN PART. The Court GRANTS Prayer A as the amendments are intended to address concerns raised by the Court in December 2017. See Order dated December 22, 2017 (Index #24); see generally, RSA 514:9; Coan v. New Hampshire Dep't of Envtl. Servs., 161 N.H.

- 1, 10–11 (2010)(" liberal amendment of pleadings is permitted unless the changes would surprise the opposing party, introduce an entirely new cause of action, or call for substantially different evidence." (quotations omitted)). Counsel is instructed to cooperate with the Clerk's Office to issue Orders of Notice to the new "Nominal Parties" as soon as practicable.
- As to Prayer B of the Motion to (I) Amend Petition and (II) File Certain Exhibits Under Seal, see Index #36, seeking permission to seal Exhibits B-1-C-1 which are identical to Exhibits B-C filed with the original Petition. See Index #1. The Petitioners seek to seal these exhibits, citing the same reasons given in its Motion to Seal filed in July 2017. See Index #2. The Court incorporates by reference the discussion in its Order dated December 22, 2017 at 5-10, see Index #24, in which the Petitioners sought closure of identical exhibits on the same basis presented today, namely that they seek to prevent interference with a criminal investigation. See Motion to (I) Amend Petition and (II) File Certain Exhibits Under Seal ¶4 (Index #36). The Court continues to conclude that "[a]Ithough the argument in favor of keeping the trust instruments sealed is somewhat thin, given the ongoing investigation of a serious homicide and, in particular, the lack of any objection to keeping them sealed, the Court will not sua sponte unseal the documents at this time." Order dated December 22, 2017 at 9-10. As such, the Court provisionally GRANTS Prayer B subject to revisiting its order should disclosure be sought by motion or petition filed with this Court.
- Consideration of the Petitioners' Motion to Compel Respondent to Adequately

  Respond to Their First Discovery Requests is **DEFERRED** pending a hearing on

the motion.<sup>1</sup> The parties are **DIRECTED** to attend a hearing on this motion on **April 3, 2018** at 9:00 a.m. at the 6<sup>th</sup> Circuit – **Probate Division** - **Concord** located at 32 Clinton Street, Concord, New Hampshire.
